Sir: On 07/11/07 at 2000 Hrs. while working the TRU/Desk, I took a walk in report for an assault. I spoke with the victim [REDACTED] Adult who stated that he was assaulted while on Hogarth St. Sgt. Ken Engel #686 has knowledge.

On 7/10/07 Sgt. Engel received a call and spoke with [REDACTED] [REDACTED] had several questions reference a sexual assault, which had taken place in 1978. [REDACTED] had been assaulted by Father Delorenzo. Sgt. Engel answered [REDACTED]'s questions, and advised [REDACTED] to make a record only complaint and I would speak with [REDACTED]. On 7/12/07 Sgt. Engel received [REDACTED]. This was the complaint of [REDACTED], with Father Vincent Delorenzo as the suspect. Sgt. Engel contacted [REDACTED] of the prosecutors office to confirm the statute of limitations on a CSC from 1978. [REDACTED] confirmed that this crime could not be prosecuted. On 7/12/07 Sgt. Engel spoke with [REDACTED] [REDACTED] gave the following statement: In April/May/June of 1978 while he was a student at [REDACTED] and only 8 yrs. old, [REDACTED] had a [REDACTED] problem. While at school he was told by a teacher, [REDACTED] [REDACTED]. Later [REDACTED] told the principal, [REDACTED] what [REDACTED] said to him. [REDACTED] sent [REDACTED] to see Father Delorenzo. After [REDACTED] spoke to Father, [REDACTED] was told to drop his pants and lean over the desk. [REDACTED] thought he was going to be disciplined. Father placed a rag in [REDACTED]'s mouth, his underwear was pulled down, a letter opener to his left ear and Father then forced his penis in [REDACTED]'s anus. Father ejaculated on [REDACTED]. After [REDACTED] was cleaned/wiped off he was sent back to class. [REDACTED] stated that the assault hurt and until a few years later he did not totally understand what had taken place. [REDACTED] stated that over the next three to four weeks incident like this and other took place five to six times. Father would call [REDACTED] to his office about [REDACTED]. Another occasion he was told to rub Father's back, as Father masturbated. After several assaults [REDACTED] told Father Steven Raica, and the assaults stopped.
